**NOTE FOR THE ATTENTION OF  
THE PROSECUTORS' COLLEGE OF THE SUPREME JUDICIAL COUNCIL OF THE REPUBLIC  
OF BULGARIA AND  
THE EVALUATION COMMITTEE OF THE SUPREME CASSATION PROSECUTOR'S OFFICE**

The purpose of this note is to inform you that for the period 16/07/2019 – 15/07/2020, Mr Stanislav Stoykov (prosecutor at the Sofia City Prosecutor's Office) is seconded as a national expert to Unit D.1 "Legislation and Anti-Fraud Programme" of the European Anti-Fraud Office (OLAF).

Mr Stoykov is part of the team dealing with the ongoing revision of Regulation (EU, Euratom) No 883/2013 (OLAF Regulation) and is also responsible for monitoring the process of transposition of Directive (EU) 2017/1371 on the fight against fraud to the Union's financial interests by means of criminal law (PIF Directive) by the Member States. In addition to these main tasks, he is OLAF's infringement correspondent and also provides general legal assistance if and where necessary.

So far, Mr Stoykov has been involved in the preparation of legislative texts and their subsequent discussions with other Commission services as well as in negotiations with the EU co-legislators – the European Parliament and the Council. Mr. Stoykov monitors the transposition of the PIF Directive in close cooperation with his colleagues from the Directorate-General for Justice and Consumers of the European Commission.

His practical experience in the field of criminal law and, in particular, in the prosecution of financial and economic crime brings added value to the work of our Unit. Mr Stoykov has contributed his expertise in a broad range of discussions internally, with national authorities responsible for the implementation of Union legislation on the fight against fraud, and with the co-legislators. In turn, Mr Stoykov is exposed to the inner workings of the policy-making and legislative cycle in the EU, and to a wide network of Union-level and national actors involved in the protection of the Union's financial interests. I am confident that the experience that Mr Stoykov is acquiring as a result of his involvement in the work of our team will also have a positive impact in his work as a prosecutor.

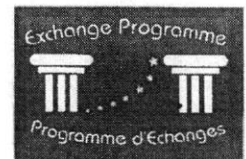
